Accident Waiver and Release of Liability

The undersigned hereby assumes any and all risks associated in participation in "Alter Dance," including, by way of example and not limitation, any risks that may arise from any negligence on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

The undersigned further acknowledges that this Accident Waiver and Release of Liability will be used by Alter Ministries, the organizer of the dance classes, in which I may participate and that it will govern my actions and responsibilities at said "Alter Dance." In consideration of my application and permitting me to participate in "Alter Dance," the undersigned hereby takes action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including, but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me, THE FOLLOWING ENTITIES OR PERSONS: Alter Ministries and those representing Alter Ministries as volunteers and contract labor.

(B) I HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned paragraph (A) from any and all liabilities or claims made as a result of participation in "Alter Dance," whether caused by negligence or otherwise. I further acknowledge that "Alter Dance," like any such physical activity, may carry with it the potential for death, serious injury, and personal loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, and the actions of other persons including, but not limited to, other participants, staff, volunteers, and spectators.

(C) I consent and agree that this accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
